REGULATIONS

The "Concorso Giancarlo Aliverta" is divided into three sections:

- Sec. A: opera competition for young artists; the winners will sing in concerts and productions with VoceAllOpera.
- Sec. B: winners will perform in G. Rossini's *Il barbiere di Siviglia*, in VAO's 2022 season.
- Sec. C: for an emerging director, who is going to direct G. Rossini's *Il barbiere di Siviglia*, in VAO's 2022 season.

Candidates can apply for only one of these three sections.

SECTION A - OPERA COMPETITION

ART, 1

The Competition is open to singers of all voice types, born on 16th October 1986 or after.

The Competition is divided into two steps:

Preliminary Round, see Art. 2 and 3;

Live auditions (First, Second and Final Round) at Spazio Teatro89 from November 4th to 7th 2021, see Art. 2, 4, 5 e 6.

APPLICATION GUIDELINES

ART. 2

The application for the Preliminary Round is free of charge.

Online applications for the Preliminary Round open on September 15th and close on October 5th 2021.

Application procedure will happen on VoceAllOpera's website (www.VoceAllOpera.com). Preparare the following attachments:

- a copy of your passport or a valid ID (must include photo and date of birth)
- a link to a video recording of 1 aria, see Art. 3

Only fully completed and correct applications submitted by October 5th will be accepted.

Applicants who were finalists on a national or international competition, and singers who have been previously cast by VoceAllOpera, will be admitted directly to the Live Auditions round, without any further step. Starting October 15th, until October 25th, they will be able to apply directly to the First Round following the application process outlined below.

On October 15th 2021, the list of candidates admitted to the First Round of Live Auditions will be published on www.VoceAllOpera.com.

Applications will be accepted between October 15th and 25th, 2021.

Please submit the following documents:

- a copy of your passport or a valid ID (must include photo and date of birth);
- repertoire (see instructions at Art. 4);
- certificates from past competitions;
- receipt of payment of the 75€ entrance fee;
- acceptance of T&C.

The entrance fee allows participants to sing at Live Auditions, given the correct issuing of applications (see Art. 1) and is non-refundable.

VoceAllOpera will accept only complete and correct applications and reserves the right to confirm with Authorities the truthfulness of information and documents provided. Incomplete applications or incorrect information will not be accepted.

REPERTOIRE

ART. 3 – PRELIMINARY ROUND

Contestants applying for <u>Section A</u> will have to send a video recording of 1 aria.

Technical requirements - video:

- It should be recorded after January 2020
- It has to be a single take
- Do not edit the sound of the videos after recording
- Recordings must be made entirely live, with piano or orchestra accompaniment
- Both in theatre and at home recordings are fine

Upload the video on YouTube choosing "public" privacy options. Videos submitted in any other way will not be taken into consideration.

On October 15th 2021, the list of candidates admitted to the First Round of Live Auditions will be published on www.VoceAllOpera.com.

ART. 4 - LIVE AUDITIONS

<u>Section A – Opera Competition</u>

For Live Auditions contestants must choose 5 arias from the compulsory repertoire list - see attachment A. All selected arias must be prepared in their entirety, in the original language, in the original key, and with accompanying recitative. Contestants must perform them by heart.

In the First Round, each singer will perform one or two arias from the submitted repertoire - the first aria may be chosen by the candidate, the second one (if requested) will be chosen by the jury, who will also have the possibility to stop the performance at any time.

During the remaining rounds, the Jury will take all the decisions.

ART. 5 – LIVE AUDITIONS GUIDELINES

Live Auditions will take place in Milan, at Spazio Teatro89 (via f.lli Zoja 89) as per the following schedule:

First Round, 4th - 5th November 2021 Second Round, 6th November 2021 Final Round, 7th November 2021

The order of appearance of the contestants for the First Round will be published on November 2nd 2021 on www.voceallopera.com. No special requests will be taken into consideration.

The Jury will inform candidates of the results at the end of each of the three Rounds. Results will be published on www.voceallopera.com as well.

During all the stages of the competition candidates will perform one or more arias selected by the Jury from their chosen repertoire.

In the First Round, contestants will choose one aria to start with and the Jury can ask for a second aria. From the Second Round onwards, the Jury will choose the aria(s) each candidate will have to perform from their chosen repertoire.

The Jury's decision is final.

The Final Round will be open to the public, unless there are changes in regulations by authorities in charge of Covid-19 management., Should it not be possible to have a live audience, VoceAllOpera will live broadcast the Final Round online.

ART. 6 – ANTI-COVID PROTOCOL AND RULES

VoceAllOpera strictly adheres to the Anti-Covid regulations and requirements issued by the relevant authorities.

All candidates who are to attend the Live Auditions must have and present the correct documentation regarding their health state, which might vary depending on the applicable laws at the time of the Competition. At present, a Green Certificate or the EU Digital Covid Certificate is necessary to take part in the Competition

It is not required to attach these documents with the application.

All candidates who are to attend the Live Auditions must respect the Protocol provided by VoceAllOpera, in order to avoid risk of infection. All candidates will receive the above mentioned Anti-Covid Protocol via email together with the audition call. Candidates must sign and fully respect the Protocol in all areas of the Theatre. Those who will not adhere to it, will be excluded from the Competition.

In case the public authority forbids the Competition to happen, VoceAllOpera reserves the possibility to reschedule the dates of Live Auditions holding as valid the results of the Preliminary Round. If, in any case, VoceAllOpera will not be allowed to make the Competition happen at all, applications will be

deleted and subcription fees will be reimbursed.

Candidates are responsible for keeping up-to-date with current anti-Covid laws and regulations both at national and local level.

established international Opera Casting Directors and General Managers, thus guaranteeing the broadest understanding of the world of opera and music.

Piano accompanists will be provided at no cost to all participants of the Live Audition rounds.

WINNERS

ART. 9

Prize-Winners for Section A commit to participate in n.3 concerts in Italy and/or abroad as part of VoceAllOpera's Season 2022.

Prizes will be issued in the form of a scholarship. Therefore, the right to obtain this grant is dependent upon regular attendance at all concerts.

In case of non-compliance,, the award and title will be forfeited and a penalty of the value of 50% of the prize will be payable to VoceAllOpera, plus the value of any additional loss sustained by the organiser of the Competition.

Prizes will be subject to tax and National Insurance contributions according to Italian law.

The Special Prize - the admission to the Accademia del Belcanto "Rodolfo Celletti" will be assigned by the Director of the Fondazione "Paolo Grassi" in Martina Franca. The award consists of the direct admission to the next edition of the Academy.

ART. 10

The Special Prize for a Young Conductor is a decision by VoceAllOpera's Artistic Committee.

ENGAGEMENTS

ART. 11

VoceAllOpera will represent at Spazio Teatro89, Milan a production of Rossini's *Il barbiere di Siviglia* in between February and May 2022.

ART. 12

VoceAllOpera has the unrestricted right to take photos, sound and video recordings during the Live Audition round, rehearsals and productions and to use these freely without further remuneration for the participants.

ART. 13

The Regulations for the Competition shall be legally binding in the Italian language version only. Any controversy shall be brought before the Court of Milan. Pursuant to Article 10, sub-section 1 of Law no.675 of 31/12/96, personal details supplied by the candidates shall be collected by VoceAllOpera in order to run the Competition. All interested parties shall be entitled to the rights specified in Article 13, above-mentioned law.
